Dear Mr. President,

On behalf of the Major Cities Chiefs Association (MCCA), I want to thank you for the assistance provided to local law enforcement under the *Families First Coronavirus Response Act* and the *CARES Act*. As our nation continues to grapple with the COVID-19 crisis, local law enforcement remains on the front lines and federal support has been instrumental. As we continue to face the COVID challenge head-on, I want to share our foreseeable challenges and concerns.

COVID-19 has already placed a strain on local budgets and police operations. To date, budgetary constraints have forced several members to cancel academy classes as well as investments like body-worn camera programs. Salaries will be cut, layoffs are imminent, and the recruitment and retention of personnel will undoubtedly remain difficult.

MCCA members have had to make drastic changes to their operations, including procuring new technology, often at significant cost, to continue offering essential services and ensure public safety. Our member agencies continue to respond to calls for service and address upticks in some of the most heinous and violent types of crime, including shootings, domestic violence, and child exploitation, despite segments of their workforce being quarantined.

On behalf of the Chiefs and Sheriffs of the sixty-nine largest law enforcement agencies in the United States, to assist local law enforcement's continued response to the COVID-19 pandemic, I respectfully request that your Administration include the following priorities in its negotiations with Congress on future COVID-19 legislation:

1. Funding for PPE and test kits

- Factor the needs of law enforcement into the criteria used to determine PPE and test kit allocations from FEMA, the Strategic National Stockpile, and other federal sources
- Expedite reprogramming requests for Byrne JAG, HSGP, and UASI funding

- Funding for sanitizing equipment to extend the life of existing PPE
2. Support local law enforcement recruitment and retention efforts
 - Pandemic pay increases and recruitment incentives—that are exempt from pay caps—for frontline local law enforcement
 - Funding for virtual training solutions for both in service and recruit training
 3. Mitigate the impact of COVID-19 on local law enforcement budgets
 - Remove the “local match” portion of federal grants
 - Funding for overtime incurred by local law enforcement to cover staffing shortages
 - Funding for hardware, software, and other equipment necessary for law enforcement to remotely accomplish essential services
 4. Assistance with addressing unique crime trends that have emerged during the COVID-19 pandemic
 5. Resources for law enforcement mental health programs
 6. Ensure any inmate release policy does not threaten public safety and health
 - Conduct an individual assessment prior to releasing any inmate that takes into account the crime(s) committed, criminal history, and proclivity to reoffend
 - Test any inmate who is going to be released for COVID-19

Thank you for your attention to this matter and your support for local law enforcement throughout the COVID-19 crisis.
