Dear Rep. Neguse,

I'm writing on behalf of the Major Cities Chiefs Association (MCCA) to register our support for H.R. 2898, the *Secure Background Checks Act of 2023*. The MCCA is a professional organization of law enforcement executives representing the largest cities in the United States and Canada.

The MCCA has long advocated for sensible firearms and gun safety policies. In 2018, the Association adopted a Firearms Violence Policy consisting of several common-sense reforms, including strengthening NICS, which is the system used to conduct a background check to determine if someone can legally purchase a firearm. To be eligible to buy a gun, individuals must meet the age requirements in federal law and any relevant age requirements in both their state of residence and the state where they are attempting to make the purchase. However, NICS does not currently check if an out-of-state purchaser meets the age requirements in their home state, which the DOJ Inspector General identified as a weakness in the system in a 2021 report.

The *Secure Background Checks Act of 2023* will help address this shortcoming by adding state-level age requirements to the list of federal prohibitors that are included in NICS checks. It is important to note that this bill does not add any additional checks to the current process or establish new requirements for obtaining a firearm. It simply closes a loophole where underage individuals who travel out of state may be able to buy a gun.
