CORPORATE PARTNER CODE OF CONDUCT

The number of corporate partners, and meeting attendees, has been determined based on the number of MCCA Member agencies. In addition to limiting the number of sponsor attendees, the MCCA will limit the number of non-MCCA law enforcement attendees at future meetings.

Before completing and returning the sponsorship form, please review the following items:

- ✓ Sponsorship payment must be made in full to secure partnership for 2025.
- ✓ Corporate partner's business practices, advocacies, outreach and efforts are expected to align with the MCCA's vision, goals and ethical standards. Any conflict must be resolved promptly with MCCA to avoid cancelation and forfeiture of sponsorship.

Conferences
